#### ORDINANCE NO. 2080

AN ORDINANCE BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND, AMENDING CHAPTER 15.32 – PLUMBING STANDARDS OF THE SALISBURY MUNICIPAL CODE TO ADOPT FATS, OILS AND GREASE REGULATIONS.

WHEREAS, the ongoing application, administration and enforcement of Chapter 15.32 of the <u>Salisbury Municipal Code</u>, demonstrates a need for its periodic review, evaluation and amendment;

WHEREAS, the Mayor and City Council wish to amend the Salisbury Municipal Code to establish regulations for fats, oils and grease.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, in regular session, that Chapter 15.32 of the <u>Salisbury Municipal Code</u> be amended as follows:

## Chapter 15.32 PLUMBING STANDARDS

#### 15.32.010 Adoption of plumbing code.

- A. The Maryland State Plumbing/Gas Code—COMAR 09.20.01, which is hereby incorporated by reference, be, and is hereby adopted as the plumbing code of the City of Salisbury in the State of Maryland, for the control of buildings and structures as herein provided, and each and all of the regulations, provisions, penalties, conditions and terms of the Code of Salisbury are hereby referred to, adopted and made a part thereof. The plumbing code so adopted is known as the "Salisbury Practical Plumbing Code 2005."
- B. The following additions and deletions are made to the Maryland State Plumbing/Gas Code:
  - 1. Section 1.10.1 Fees Schedule shall be deleted in its entirety. Plumbing permit fees shall be set by resolution ordinance of the council from time to time. (Ord. 2001, 2006: Ord. 1964, 2005)
- C. The 2007 Washington Suburban Sanitary Commission Fats, Oils, and Grease Requirements, Section 103 Interceptors and Separators is hereby adopted, with amendments, as part of the "Salisbury Practical Plumbing Code."

AND BE IT FURTHER ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, that the amendments set forth in this Ordinance shall take effect from and after the date of its final passage.

THE ABOVE ORDINANCE was introduced at a meeting of the Council on the 22<sup>nd</sup> day of June, 2009, and having been published as required by law, in the meantime, was finally passed at its meeting on the 27<sup>th</sup> day of July, 2009.

Amending City of Salisbury Practical Plumbing Code

Attached is an ordinance which amends the Salisbury Practical Plumbing Code to include the 2007 Washington Suburban Sanitary Commission Fats, Oils and Grease Requirements.

The State Plumbing Code is a minimum code which applies state wide and allows local jurisdictions to make amendments or adopt more stringent requirements based upon their particular needs. The purpose of the code is to prescribe minimum requirements necessary for the protection of health and safety through proper design of plumbing systems. Additionally, with the input and recommendation from the Department of Public Works, I've included the adoption of the 2007 Washington Suburban Sanitary Commission section regarding fats, oils and grease requirements to provide a higher level of regulation and protection from such discharge from entering the waste water treatment plant.
