ORDINANCE NO. 2113

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF SALISBURY TO ESTABLISH THE FEE SCHEDULE FOR A SIDEWALK CAFÉ PERMIT FEE AND AN ANNUAL SIDEWALK CAFÉ RENEWAL FEE

WHEREAS, Section 12.36.020(A) of the Salisbury Municipal Code requires that a sidewalk café permit be obtained to construct, maintain, use or operate a sidewalk café on a public sidewalk;

WHEREAS, Section 12.36.020 (C) of the Salisbury Municipal Code provides that a sidewalk café permit shall be for one year from March 1 of each year until the following February 28;

WHEREAS, Section 12.36.020 (C) of the Salisbury Municipal Code provides that an annual permit fee and the annual renewal permit fee shall be established by Ordinance of the City Council;

WHEREAS, the City Council desires to establish fees for the sidewalk café permit and the annual renewal permit fee;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the City Council of the City of Salisbury, Maryland, in regular session, that the sidewalk café permit fee shall be fifty dollars (\$50.00);

AND BE IT FURTHER ENACTED AND ORDAINED by the City Council of the City of Salisbury, Maryland, in regular session, that the annual renewal sidewalk café permit fee shall be fifty dollars (\$50.00);

AND BE IT FURTHER ENACTED AND ORDAINED by the City Council of the City of Salisbury, Maryland, that the fees set forth in this Ordinance shall take effect upon final passage.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on the 14th day of June, 2010, and having been published as required by law, in the meantime, was finally passed by the Council on the 26th day of July, 2010.
