

**ORDINANCE NO. 2132**  
**AS AMENDED ON SECOND READING – DECEMBER 13, 2010**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY 11 GENERAL FUND BUDGET TO APPROPRIATE ADDITIONAL FUNDS TO PAY FOR ADVERTISING COSTS ASSOCIATED WITH ADMINISTRATIVE APPEALS UNDER THE CITY ZONING CODE.

WHEREAS, Chapter 17.12.110 of the City Code provides that persons aggrieved by a decision of the Building Inspector may take an appeal (“Administrative Appeal”) to the Board of Zoning Appeals (“the Board”), and;

WHEREAS, Chapter 17.12.120 of the City Code requires that all appeals be considered by the Board at a Public Hearing, and;

WHEREAS, Chapter 17.04.150 of the City Code requires that Public Hearings before the Board be advertised in a newspaper of general circulation, and;

WHEREAS, the City of Salisbury has determined that it is appropriate for the City to pay the cost of legal advertisement for required public hearings associated with certain Administrative Appeals under the Zoning Code, and;

WHEREAS, in the FY 2011 General Fund budget, the City provided no funds for this purpose, and;

WHEREAS, there is not sufficient funds in the Planning & Zoning Department budget to increase the amount necessary for legal advertisement, and;

WHEREAS, there is sufficient balance in the General Fund contingency to allow for this transfer;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City’s Fiscal Year 2011 General Fund budget be and is hereby, amended as follows:


- 1) Decrease the Debt Service & Other Uses by \$3,000.
- 2) Increase the Planning & Zoning Department by \$3,000.

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on the 22<sup>nd</sup> day of November, 2010 and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 13<sup>th</sup> day of December, 2010.
