

ORDINANCE NO. 2168

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND AMENDING ORDINANCE NO. 2152 SECTION A – LOT RATES TO ADD A PARKING PERMIT RATE FOR PARKING LOT #14, EFFECTIVE SEPTEMBER 1, 2011.

WHEREAS, the parking lot near the Holiday Inn is known as lot #14; and

WHEREAS, a number of people, who work in the downtown area have expressed an interest in parking in Lot #14;

WHEREAS, in order to accommodate this demand, the City desires to allow permits to be sold for the lot.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Salisbury the following parking rate schedule, which adds permit rate for Lot #14, shall be adopted by the City of Salisbury:

A. Lot Rates

B. Parking Meters:

All meters with the exception of Lot 9, rates will be \$0.25 per 20 minutes. Lot 9 rates will be \$0.25 per 30 minutes.


C. Manned Lots:

1. Parking Lot #1 shall have free parking for the first two (2) hours and all hours thereafter will be \$1.00 per hour.
2. The City's parking garage will have an hourly rate of \$0.50 per hour beginning with the first hour. There will be no free hourly parking in the Parking Garage.

THIS ORDINANCE, was introduced and read at a meeting of the Council of the City of Salisbury, Maryland held on the 8th day of August, 2011, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 22nd day of August, 2011 and become effective for all purchases September 1, 2011 and thereafter.

Re: Parking Lot #14

As discussed at the August 1, 2011 work session, Parking lot #14 is located on the south side of the East prong of the Wicomico River by the Holiday Inn. The lot currently has 22 unmetered, unpermitted spaces. This is a free lot for access to the river walk. We have received some requests from downtown employees who would desire purchasing permits to the lot. We discussed the lot with CCDC and it was the recommendation of the group to make a portion of the lot metered and a portion of the lot permit. We talked with the Holiday Inn about leasing some spaces and they stated they have enough parking and thus do not need our lot.

Thus we are requesting that City Council set a permit rate of \$20 per month for 15 spaces, 1 free handicap space and that we have 6 spaces metered. The meters would be 2 hour meters at \$0.25 per 20 minutes. The permit rate is above our non-core rate of \$9 per month, but lower than other rates due to the walk from the business district. Management has included this permit rate in the ordinance that amends ordinance 2152. If you have any questions about this information, please let me know.
