ORDINANCE NO. 2178 AS AMENDED ON NOVEMBER 28, 2011

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET ADMENDMENT OF THE FY12 GENERAL FUND TO APPROPRIATE THE FUNDS RECEIVED FROM THE LOCAL GOVERNMENT INSURANCE TRUST (LGIT) FOR TWO EMERGENCY POLICE VEHICLES WHICH WERE INVOLVED IN ACCIDENTS AND DEEMED A TOTAL LOSS WITH THE INTENTION OF ARRANGING A LEASE-PURCHASE OF TWO ONE NEW VEHICLES <u>AND PURCHASE OF A SECOND VEHICLE</u>.

WHEREAS, both Unit #45 (2002 Ford Crown Victoria, VIN# 2FAFP71W12X113855) and Unit #21 (2008 Ford Crown Victoria, VIN# 2FAFP71VX8X106824) were involved in motor vehicle accidents and declared a total loss by the Local Government Insurance Trust; and

WHEREAS, Unit #45 was valued at \$4,400.00 and Unit #21 was valued at \$10,150.00, by the Local Government Insurance Trust and this amount of money totaling \$14,550.00 was paid to the City of Salisbury and placed in the General Fund; and

WHEREAS, the Salisbury Police Department has a need to replace these vehicles in order to continue its current level of services; and

WHEREAS, in order to provide funding for replacement vehicles, the Police Department requests these funds be transferred from the General Fund to their Vehicle Acct. #21021-577025; and

WHEREAS, the four new vehicles purchased in FY12 came in under budget leaving \$16,000.00 available and the Salisbury Police Department will combine the \$14,550.00 from the Local Government Insurance Trust with surplus funds in the Vehicle Account #21021-577025 and use these combined funds totaling \$30,450.00 to lease_purchase one two new police vehicles and purchase of a second vehicle.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF SALISBURY, MARYLAND, that the City's Fiscal year 2012 General Fund Budget be amended as follows:

1) Increase General Fund Revenue – Insurance Proceeds (01000-456935) by \$14,550.00

2) Increase the Police Department budget by \$14,550.00

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on this 14th day of November, 2011, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 28th day of November, 2011.


