

ORDINANCE NO. 2180

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY12 FIRE DEPARTMENT BUDGET TO ACCEPT AND APPROPRIATE ADDITIONAL FUNDS ASSOCIATED WITH PROVIDING MEDICAL/PHYSICAL SCREENING FOR THE VOLUNTEER MEMBERS OF THE DEPARTMENT.

WHEREAS, in the FY 2012 Fire Volunteer budget account 24040-513040, the City provided \$27,075.00 for medical/physical screening; and

WHEREAS, the City has received \$8,357.13 in medical/physical screening reimbursement revenue from Wicomico County; and

WHEREAS, there are is an increased demand for volunteer medical/physicals for the remainder of FY2012; and

WHEREAS, the additional revenue will be expensed to cover the increased demand for volunteer medical/physicals for the remainder of FY2012;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2012 Fire Department budget be and is hereby, amended as follows:


- 1) Increase the General Fund Revenue - Donations by \$8,357.13
- 2) Increase the Fire budget by \$8,357.13

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on the 14th day of November, 2011, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 28th day of November, 2011.
