ORDINANCE NO. 2192

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY12 GENERAL FUND BUDGET AND THE FY12 STREET LIGHTING BUDGETARY ACCOUNT TO APPROPRIATE ADDITIONAL FUNDS TO PAY THE PROJECTED COST OF LIGHTING FACILITIES MAINTENANCE.

WHEREAS, street lights at the following locations are currently not functioning because of faulty direct-buried underground wiring:

- West Carroll Street between Camden Avenue and Waverly Drive
- West Naylor Mill Road between Scenic Drive and Goddard Parkway; and

WHEREAS, Salisbury Public Works has determined that restoration of those lights will require replacement of the faulty wiring with new underground conduit and pulled new electrical cable for a distance of 470 LF at the West Carroll Street location and 930 LF at the West Naylor Mill Road location; and

WHEREAS, the Street Lighting account will need to be increased to accommodate these efforts;


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2012 General Fund budget and Street Lighting budget be and are hereby, amended as follows:


1. Increase the Surplus account for the General Fund by \$17,500.00
2. Increase the Street Lighting Budget by \$17,500.00

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.


THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on the 13th day of February, 2012, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 27th day of February 2012.

SUBJECT: Street Lighting Budget Amendment

Street lights at the locations described below are currently not functioning because of faulty underground wiring. Salisbury Public Works has determined that maintenance efforts will need allocation of additional funds in the FY 12 equipment account for Street Lighting to make those existing lights once again operational at the following locations:

- West Carroll Street between Camden Avenue and Waverly Drive – replacement of faulty direct-buried underground wiring with 470 LF of new conduit and pull new electrical cable; and
- West Naylor Mill Road between Scenic Drive and Goddard Parkway – replacement of faulty direct-buried underground wiring with 930 LF of new conduit and pull new electrical cable.

The cost for the repairs is \$17,500.00. We are requesting a budget amendment for the Street Lighting account.
