

ORDINANCE NO. 2419

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY17 BUDGET TO APPROPRIATE FUNDS FOR TRAFFIC EQUIPMENT AND OPERATING.

WHEREAS, as a result of a work performed by the Wicomico County Board of Education for the construction of Bennett High School, improvements to street lights were required along College Avenue; and

WHEREAS, the City of Salisbury Traffic Division of the Public Works Department purchased and installed the necessary street lights; and

WHEREAS, the Wicomico County Board of Education reimbursed the City for actual material expenses; and

WHEREAS, the Street Lighting budget should be increased to accommodate these efforts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2017 budget and Street Lighting budget be and are hereby amended as follows:

1. Increase the Miscellaneous Revenue (01000-456911) account by \$14,941.00
2. Increase the Highway Lighting (31152-556201) account by \$14,941.00


BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.



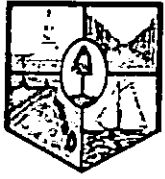

Re: Budget Amendment – Street lights on College Avenue

The Department of Public Works requests a budget amendment to move funds to an operating account from miscellaneous revenue. The Traffic Branch installed seven (7) street lights on College Avenue in front of Bennett High School. The work was performed in accordance with an agreement with the Wicomico County Board of Education when Bennett High School was built. The installation allowed the street lights to be owned and maintained by the City of Salisbury and utilize low energy LED lights. The Wicomico Board of Education has reimbursed the City for the actual material expenses in the amount of \$14,941.00. Public Works requests that the reimbursement be transferred to the Street lighting electric account.
