ORDINANCE NO. 2421

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET AMENDMENT OF THE FY17 GENERAL FUND BUDGET TO APPROPRIATE INSURANCE PROCEEDS AND A REFUND RECEIVED IN FY17 TO AID IN THE PURCHASE OF A REPLACEMENT VEHICLE FOR THE POLICE FLEET.

WHEREAS, Salisbury Police Animal Control Unit #AC1, a 2003 Ford F150 King Cab, VIN 1FTRX17WX3NA30648 was involved in a motor vehicle accident and deemed a total loss; and

WHEREAS, the City received an insurance adjustment for vehicle #AC1 in the amount of \$6,655.00; and

WHEREAS, Salisbury Police Patrol Unit #1362, a 2013 Chevrolet Caprice, VIN 6G1MK5U38DL819299 and Patrol Unit #1475, a 2014 Chevrolet Caprice, VIN 6G3NS5U34EL962733 sustained damage due to a severe rain storm; and

WHEREAS, the City received an insurance adjustment for the repairs of Units #1362 and #1475 in the amount of \$4,305.93; and

WHEREAS, the Salisbury Police Animal Control Unit #AC1 needs to be replaced; and

WHEREAS, replacement of this vehicle will allow Salisbury Police Department (SPD) to maintain a sufficient number of Animal Control vehicles to effectively patrol all areas of the City; and

WHEREAS, SPD is requesting the insurance adjustment for vehicle #AC1 in the amount of \$6,655.00, and the insurance adjustment for Units #1362 and #1475 of \$4,305.93, be placed in the SPD Police Services, Vehicle Account, 21021-577025; and

WHEREAS, SPD will utilize the funds appropriated from the insurance adjustments and the refund check to purchase a new Animal Control vehicle.


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2017 General Fund Budget and is hereby, amended as follows:

- 1) Increase Insurance Proceeds (01000-456935) by \$6,655.00
- 2) Increase Insurance Proceeds (01000-456935) by \$4,305.93
- 3) Increase the Police Department budget by \$10,960.93 ~~\$11,958.11~~


BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.



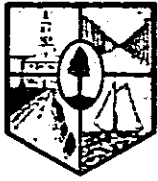

SPD Patrol Units #1362, a 2013 Chevrolet Caprice, VIN 6G1MK5U3DL819299 and Unit #1475, a 2014 Chevrolet Caprice, VIN 6G3NS5U34EL962733 sustained damage due to a severer rain storm. These vehicles have been repaired and put back into the fleet.

SPD requests that the insurance adjustment from the above vehicles totaling \$10,960.93 be transferred to the SPD Police Services Vehicle Account, 21021-577025 to be used towards the purchase of a new animal control vehicle and related equipment.
