ORDINANCE NO. 2471

AN ORDINANCE OF THE CITY OF SALISBURY TO ESTABLISH A NON-PROFIT PARKING PERMIT RATE AND TO APPROVE A TEMPORARY CHANGE IN PARKING FEES FOR ALL GOVERNMENTAL ENTITIES' PARKING PERMITS, EFFECTIVE JANUARY 1, 2018.

WHEREAS, the City of Salisbury desires to reduce parking permit fees for non-profit organizations operating in the Central Business District and parking within the Downtown Parking District; and

WHEREAS, some non-profit organizations pay for their employees' parking permits within the Downtown Parking District; and


WHEREAS, the City of Salisbury desires to temporarily waive the parking permit fee increases established in the 2018 fee schedule for all the parking fees paid by all governmental entities ~~Wicomico County, Maryland~~ on behalf of their ~~its~~ employees working in the Central Business District and parking within the Downtown Parking district.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Salisbury, that a "Non-profit Parking Rate" be established, which shall reduce parking permit fees by 25% for Downtown Parking District parking permits purchased by non-profit organizations operating in the Downtown Business District, and which shall become effective January 1, 2018; and

BE IT FURTHER ORDAINED by the City Council of the City of Salisbury, that there shall be a temporary stay of fee increases shown in the 2018 fee schedule for all Downtown Parking District parking permits purchased by all Governmental Entities for their employees, effective January 2018 to June 2018.

AND BE IT FURTHER ORDAINED AND ENACTED that this Ordinance was introduced at a meeting of the City Council held on 11<sup>th</sup> day of December, 2017 and duly passed at a meeting of the Council of the City of Salisbury, Maryland held on the 18<sup>th</sup> day of December, 2017 and is to become effective as of January 1, 2018.

Attached is the ordinance (1) to establish a “Non-Profit Rate” which will be a 25% reduction to regular rates for parking permits, and (2) to approve a temporary change (fee increase waiver) to parking permit rates for Wicomico County Government employees from January 2018 through June 2018. The waiver for Wicomico County parking permits will alleviate potential budget shortfalls that were created when County Departments did not budget for parking permit fee increase in their FY18 budgets.
