ORDINANCE NO. 2472

AN ORDINANCE OF THE CITY OF SALISBURY, MARYLAND TO AMEND THE FY 2018 FEE SCHEDULE TO ESTABLISH SEPARATE RATES FOR TRANSIENT PARKING PAY STATIONS.

WHEREAS, the City established a Fee Schedule with the adoption of the Fiscal Year 2018 Budget of the City of Salisbury; and

WHEREAS, the City will be installing Pay Stations for use of some of the City's transient parking spots; and

WHEREAS, the fees listed in the 2018 Fee Schedule, passed with Ordinance 2425 had Parking Meters and Pay Stations listed at the same rate; and

WHEREAS, the Pay Stations will allow transient parkers to pay for multiple hours of parking at one time; and

WHEREAS, the City desires to limit the number of hours that may be paid at one time to 3 hours and charge a premium rate for use of the Pay Station parking spot in excess of 2 hours in a row; and

WHEREAS, the remaining fees in the 2018 Fee Schedule shall remain as currently set forth in the Salisbury Municipal Code.


NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF SALISBURY THAT the amended fee amounts in the attached Exhibit 1 – FY 2018 Fee Schedule – Parking Permits and Fees be amended by the City of Salisbury and the amounts set forth therein shall supersede the corresponding fee amounts prescribed in the Salisbury Municipal Code.

AND BE IT FURTHER ORDAINED AND ENACTED that this Ordinance was introduced at a meeting of the City Council held on the 11th day of December, 2017 and duly passed at a meeting of the Council of the City of Salisbury, Maryland held on the 18th day of December, 2017 and is to become effective as of January 1, 2018.
