A RESOLUTON OF THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND TO REVISE THE TIME LIMIT FOR THE COMMERCIAL LOADING ZONE IN FRONT OF SANDI'S ONE STOP LOCATED AT 701 W. MAIN STREET FROM 10 MINUTES TO 20 MINUTES TO ALLOW ADDITIONAL TIME FOR DELIVERIES

WHEREAS, the owner of Sandi's One Stop convenience store has requested a change in the time limit for commercial deliveries to her business; and

WHEREAS, the current time limit of 10 minutes does not allow enough time for commercial deliveries, a change to a 20-minute limit is acceptable; and

WHEREAS, the owner of Sandi's One Stop has assured her cooperation to proactively prevent illegal drug activity at this location, with the stipulation if criminal activity begins to occur this time limit would be revised accordingly by the Chief of Police.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the time limit for commercial deliveries to Sandi's One Stop located at 701 W. Main Street, Salisbury, Maryland be extended from 10 minutes to 20 minutes.

In June, I met with Ms. Barbara Cornish, the owner of Sandi's One Stop. at 701 W. Main Street. Ms. Cornish requested that the time limit for the commercial loading zone in front of her business be extended from 10 minutes to 20 minutes. She stated that 10 minutes just wasn't enough time to unload deliveries.

I expressed my concern of this location's history of illegal drug activity and vehicles parked for long periods of time allow individuals to engage in criminal activity by using the vehicles as a visual barrier. Ms. Cornish agreed to remain vigilant and to take proactive steps to prevent this activity. I advised her that I would recommend the extended time period with the understanding that should criminal activity begin again in the area, the loading zone time would be revised.
