A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND ACCEPTING THE DONATION OF TWO RAY ALLEN, INC., CRUISE-EZE K-9 VEHICLE INSERTS FROM THE WORCESTER COUNTY SHERIFF'S DEPARTMENT FOR USE IN THE SALISBURY POLICE DEPARTMENT'S K-9 PROGRAM

WHEREAS, the Worcester County Sheriff's Department has offered to donate two Ray Allen, Inc., Cruise-Eze K-9 vehicle inserts to the Salisbury Police Department; and

WHEREAS, these vehicle inserts have been inspected by personnel from the Salisbury Police Department and have been found to be in good condition and acceptable for use in the department's vehicles; and

WHEREAS, the purpose of the insert is to safely and efficiently transport a Police K-9 during the course of duty; and




