




BE IT RESOLVED, by the City of Salisbury, that the following individual is reappointed to the Historic District Commission for the term ending as indicated:

The above resolution was introduced, read and passed at the regular meeting of the Council of the City of Salisbury held on the 12<sup>th</sup> day of December, 2011.


