A RESOLUTION OF THE CITY OF SALISBURY ACCEPTING FUNDS FROM THE WICOMICO COUNTY CIRCUIT COURT - ADULT DRUG COURT DISCRETIONARY ADMINISTERED THROUGH THE MARYLAND JUDICIARY ADMINISTRATIVE OFFICE OF THE COURTS TO PROVIDE FOR OVERTIME REIMBURSEMENT TO POLICE OFFICERS PERFORMING COMPLIANCE CHECKS OF SUBJECTS PARTICIPATING IN THE WICOMICO COUNTY CIRCUIT COURT ADULT DRUG TREATMENT PROGRAM.

WHEREAS, grant funding has been awarded to the Salisbury Police Department through the Maryland Judiciary Administrative Office of the Courts; and

WHEREAS, the Wicomico County Circuit Court Adult Drug Treatment Program and the Salisbury Police Department will cooperate successfully in serving the people of the City of Salisbury; and


WHEREAS, these funds will be used for officers working overtime hours to perform compliance checks to reduce the number of repetitive crimes committed by addicted drug offenders and to increase the completion percentage of those who are court ordered into substance abuse treatment; and


WHEREAS, the use of overtime funding for compliance checks will provide for effective court supervision and return repeat offenders to the community as productive law abiding citizens.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that grant funds of \$9,152.00 be accepted and used for overtime reimbursement to reduce the number of repeat drug related crimes committed by addicted offenders and to increase the level of safety for the citizens of Salisbury.


THIS RESOLUTION was duly passed at a meeting of the Council of the City of Salisbury held on April 9, 2012, and is to become effective immediately upon adoption.
