

RESOLUTION No. 2192

A RESOLUTION OF THE CITY OF SALISBURY ACCEPTING A 1994 CHEVROLET CAPRICE WHICH WAS FORFIETED TO THE SALISBURY POLICE DEPARTMENT, THROUGH THE WICOMICO COUNTY CIRCUIT COURT, AND IS REQUESTING THAT THE VEHICLE BE DECLARED SURPLUS AND SOLD AT AUCTION WITH THE PROCEEDS GOING TO THE CITY'S GENERAL FUND.

WHEREAS, a 1994 Chevrolet Caprice, VIN#1G1BN52W9RR13026 was forfeited to the Salisbury Police Department by the Circuit Court for Wicomico County, Maryland; and

WHEREAS, this vehicle has an approximate value of \$500.00; and

WHEREAS, the repairs needed on this vehicle exceed the value and the Police Department has no need of this vehicle; and


WHEREAS, the Salisbury Police Department requests that the vehicle be accepted by the Council and immediately declared surplus; and


WHEREAS, the vehicle would be auctioned off by PropertyRoom.com with the proceeds being placed in the City's General Fund.


