

RESOLUTION No. 2224

A RESOLUTION OF THE CITY OF SALISBURY TO ACCEPT FUNDS IN COOPERATION WITH THE MARYLAND OFFICE OF HIGHWAY SAFETY TO PROVIDE OVERTIME REIMBURSEMENT TO POLICE OFFICERS PARTICIPATING IN A SPECIAL TRAFFIC ENFORCEMENT PROGRAM ENTITLED "DUI ENFORCEMENT," TO REDUCE THE OCCURRENCE OF PERSONS DRIVING UNDER THE INFLUENCE OF ALCOHOL THROUGH THE USE OF CHECKPOINTS AND SATURATION PATROLS.

WHEREAS, the Maryland Office of Highway Safety and the Salisbury Police Department will cooperate successfully in serving the people of Salisbury/Wicomico County; and

WHEREAS, this funding is designated for overtime reimbursement for Police Officers working this DUI Enforcement program to target persons driving under the influence of alcohol; and


WHEREAS, officers will utilized checkpoints and saturation patrols to target persons driving under the influence of alcohol; and

WHEREAS, officers working this traffic enforcement program will submit activity and performance reports to track the success of this program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that Grant funds in the amount of \$3,990.00 be accepted and used for overtime reimbursement to reduce the occurrence of persons operating a motor vehicle while under the influence of alcohol.
