

RESOLUTION No. 2226

A RESOLUTION OF THE CITY OF SALISBURY ACCEPTING FUNDS IN COOPERATION WITH THE MARYLAND OFFICE OF HIGHWAY SAFETY TO PROVIDE OVERTIME REIMBURSEMENT TO POLICE OFFICERS PARTICIPATING IN A SPECIAL ENFORCEMENT PROGRAM ENTITLED "COMPREHENSIVE ENFORCEMENT," TO REDUCE THE OCCURRENCE OF UNSAFE AND UNLAWFUL ACTIONS OF DRIVERS WHO DEMONSTRATE A CONSCIOUS AND WILLFUL DISREGARD OF TRAFFIC SAFETY.

WHEREAS, the Maryland Office of Highway Safety and the Salisbury Police Department will cooperate successfully in serving the people of Salisbury/Wicomico County; and

WHEREAS, this grant funding has been designated to reimburse officers for overtime hours worked on proactive traffic safety enforcement efforts; and


WHEREAS, the use of these overtime funds will allow increased police presence for traffic enforcement to be used at the discretion of the Salisbury Police Department.

WHEREAS, officers working this traffic enforcement program will submit activity and performance sheets to track the success of this program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that Grant funds in the amount of \$4,950.00 be accepted and used for overtime reimbursement to reduce the occurrence of drivers operating a motor vehicle while demonstrating a conscious disregard for traffic safety.

THIS RESOLUTION was duly passed at a meeting of the Council of the City of Salisbury held on November 13, 2012, and is to become effective immediately upon adoption.
