RESOLUTION No. 2228

A RESOLUTION OF THE CITY OF SALISBURY ACCEPTING GRANT FUNDS IN COOPERATION WITH THE MARYLAND OFFICE OF HIGHWAY SAFETY TO PROVIDE OVERTIME REIMBURSEMENT TO POLICE OFFICERS PARTICIPATING IN A SPECIAL ENFORCEMENT PROGRAM ENTITLED "SMOOTH OPERATOR," TO REDUCE THE OCCURRENCE OF AGGRESSIVE, UNSAFE AND UNLAWFUL ACTIONS OF MOTOR VEHICLE DRIVERS WHO DEMONSTRATE A CONSCIOUS AND WILLFUL DISREGARD OF FOR TRAFFIC SAFETY.

WHEREAS, the Maryland Office of Highway Safety and the Salisbury Police Department will cooperate successfully in serving the people of Salisbury/Wicomico County; and

WHEREAS, this grant funding has been designated for officers working overtime hours proactively targeting aggressive motor vehicle drivers; and


WHEREAS, the use of these overtime funds will allow increased police presence for this "Smooth Operator" enforcement effort; and


WHEREAS, these funds must be used on the specific dates which will be established by the Maryland Highway Safety Administration.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that grant funds in the amount of \$1,120.00 be accepted and used for overtime reimbursement to reduce the occurrence of aggressive drivers operating a motor vehicle while demonstrating a conscious disregard for safety.

THIS RESOLUTION was duly passed at a meeting of the Council of the City of Salisbury held on November 13, 2012, and is to become effective immediately upon adoption.


