WHEREAS, the Donor and the City recognize the importance of city park facilities and amenities; and	
WHEREAS, the Donor has offered to donate a memorial park bench.	
NOW, THEREFORE, the City and the Donor, for the consideration and under the described conditions and obligations, hereinafter set forth, agree as follows:	
Section 1.	The donation, known as the Memorial Park Bench in memory of Dominick R. Raffaele, described below, is donated in its entirety to the citizens of Salisbury to be hereafter owned by the City of Salisbury and managed on behalf of the citizens by the Department of Public Works.
Section 2.	Description and Location: The item is a six (6) foot long, surface mount bench with brown Trex slats and a green frame. The slats will be engraved with the text "In Memory Of Dominick R. Raffaele." The bench will be installed on a concrete pad. The bench will be located in the Salisbury City Park.
Section 3.	Maintenance: The City shall be responsible for maintenance of the item, including any reasonable repairs, and will have the discretion to not replace or repair the donation if it is deemed damaged beyond reasonable repair, suffers repeated vandalism, or has exceeded its useful life. Maintenance or replacement of the item will be at the City's sole discretion.
