WHEREAS, the City of Salisbury submitted a grant application requesting funding from the Local Government Insurance Trust to provide snow plow simulator training for eight employees; and


WHEREAS, the City of Salisbury's grant application was approved by the Local Government Insurance Trust in the amount of \$2,400; and

WHEREAS, the grant was awarded to the City of Salisbury.





Re: Accepting a Training Grant from LGIT

The Local Government Insurance Fund (LGIT), the City of Salisbury's Liability insurance company offers its members the opportunity to apply for safety training grants. These grants are to be used by employers to assist with training to reduce liability claims.

The City of Salisbury applied for a grant in the amount of \$2,400 to provide a snow plow operator simulator training class for Department of Public Works employees. This class will be given to eight (8) employees to train snow plow operators under varying simulated adverse conditions to improve driving skills in a realistic but safe environment. The training is provided by L3 Communications which has developed simulators for the military. This training was performed in Hartford and Cecil counties last year and was recommended by their DPW staff.

LGIT approved this grant application and has awarded the City of Salisbury \$2,400 to cover the cost of this training. LGIT plans to notify other shore members of the opportunity to apply for grants to take advantage of this training along with the City. We are currently working to schedule the training at the end of September 2014.
