

RESOLUTION NO. 2721

A RESOLUTION OF THE CITY OF SALISBURY, MARYLAND APPROVING AND ADOPTING 2017 SALISBURY URBAN GREENWAY MASTER PLAN

WHEREAS, the 2017 *Salisbury Urban Greenway Plan* is a guiding document for the Mayor, City Council, and developers of Salisbury, setting forth recommendations for implementing a greenway trail connecting Lakeside at Mallard Landing Assisted Living Facility to Pemberton Historical Park; and

WHEREAS, the 2017 *Salisbury Urban Greenway Plan* designates the alignments, facility types, and planning-level cost estimates for the 11 segments of the proposed greenway trail; and

WHEREAS, the City of Salisbury strives to promote safe walking and cycling opportunities for persons of all ages and abilities by creating a greenway trail connecting citizens and visitors to destinations and major activity generators; and

WHEREAS, the development and implementation of the Plan demonstrates the commitment of City officials to establish a greenway trail to provide an alternate mode of transportation, improve public health, and for the City to emerge into a major low impact ecotourism destination; and


WHEREAS, the implementation of the recommendations contained in the Plan are contingent upon future capital programming considerations from a variety of sources and multiple jurisdictions; and




THIS RESOLUTION was duly passed at a meeting of the Council of the City of Salisbury held on February 13, 2017, and is to become effective immediately upon adoption.

In 2016, the Salisbury-Wicomico Department of Planning, Zoning, and Community Development retained professional planning services to assist with the development of an Urban Greenway Master Plan. The Plan contains a recommended bicyclist and pedestrian route, path facility types, and planning-level cost estimates to construct the various segments of the Urban Greenway path. As proposed, the Urban Greenway will connect Mallard Landing Retirement Community to Pemberton Park, as well as activity centers between the two destinations (e.g. Ward Museum, City Zoo and Park, Ben's Red Swings, Downtown, etc).

Contingent upon a satisfactory review at City Council work session on January 3, 2017, Staff recommends City Council adoption of the Draft *Salisbury Urban Greenway Master Plan*, via resolution, at a legislative meeting in the near future.
