ORDINANCE NO. 2182

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY12 WATER AND SEWER FUND BUDGET.

WHEREAS, the FY12 Water and Sewer Fund budget was created with certain estimates for legal services, and;

WHEREAS, as the year has progressed it has been determined that those estimates will not be sufficient to cover all of the costs of the City's Wastewater Treatment Plant litigation attorneys, Goldberg, Besche & Banks, P.C., the City attorney, expert testimony and other litigation expenses, and:

WHEREAS, the City Council desires to update the budget to reflect new estimates;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2012 Water and Sewer Fund budget be and is hereby amended as follows:

- 1) Increase the current surplus account for the Water and Sewer Fund by \$667,500
- 2) Increase the Water and Sewer Fund expenses by \$667,500

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.



Litigation Costs

As discussed, the OBG/CDG litigation is ramping up as we work towards the new November trial date. Goldberg, Besche & Banks, P.C. and Webb, Burnett, Cornbrooks, Wilber, Vorhis, Douse & Mason, LLP have provided their cost estimates for the remainder of the fiscal year. We will need expert testimony to prove our liability case so funds are also included for the expert opinions and other litigation support expenses.

Attached is an updated spreadsheet with the estimated expenses. The updated figures include additional funds for the expert testimony from the engineering firm Brown and Caldwell, the construction management expert, Mr. Wilkinson and deposition costs. The current 87000 Sewer Administration budget can cover the litigation expenses through December. We are requesting a budget increase of \$667,500 be added to the Sewer Fund expenses to cover the projected litigation costs for the remainder of FY12.
