ORDINANCE NO. 2478

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET AMENDMENT OF THE CAPITAL PROJECT FUND ~~FY2018 FIRE DEPARTMENT BUDGET~~ TO APPROPRIATE FUNDS TO THE RADIO COMMUNICATION PROJECT USING FUNDS DONATED TO THE CITY FROM THE CITY'S GENERAL FUND DONATIONS ACCOUNT TO THE FIRE DEPARTMENT'S VEHICLES AND EQUIPMENT ACCOUNTS.

WHEREAS, the City of Salisbury Fire Department was notified by the Claudell Bowdle, Jr. Revocable Trust (Trust) that it was named as a beneficiary of the Trust; and

WHEREAS, the Trust has executed the distribution of funds in the amount of \$120,958.47, pursuant to Article IV.B.2.b of the Trust; and

WHEREAS, the City of Salisbury Fire Department is in receipt of monies equal to its share as outlined in the Trust; and

WHEREAS, funds appropriated are to be used enhance its capabilities in providing the effective and efficient delivery of fire, rescue and emergency medical services; and

WHEREAS, the City of Salisbury Fire Department desires to allocate the funds to the Radio Communication Project ~~purchase various apparatus and equipment with a total value of \$120,958.47 for inclusion in its inventory of emergency vehicles and equipment; and~~

WHEREAS, both the Fire Chief and the Mayor have recommended that the City accept the monetary donation and allocate the funds to the Radio Communication Project ~~Fire Department FY2018 Operating Budget.~~


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND, THAT the General Capital Project ~~Fiscal Year 2018 General Fund Budget~~ be amended as follows:


- 1) Increase Donation Revenue (98018-456415-48033 ~~01000-456400~~) by \$ 120,958.47
- 2) Increase Equipment ~~Fire Department~~ (98118-577030-48033 ~~24035-577025~~) by \$ 120,958.47 ~~\$ 40,000.00~~
- 3) Increase ~~Fire Department~~ (~~24035-577030~~) by ~~\$ 80,958.47~~

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.


