## **ORDINANCE NO. 2486**

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY 2018 GENERAL FUND BUDGET TO APPROPRIATE FUNDING TO THE CLERKS OFFICE TRAINING ACCOUNT.

WHEREAS, the City has budgeted in the City Clerk Training/Schools Account funds for registration fees for the City Clerk and Assistant City Clerk to attend conferences and continued education classes; and

WHEREAS, registration fees were paid to the International Institute of Municipal Clerks in the amount of \$1,066.00 in November 2017 for the Assistant City Clerk to attend the Annual Conference and Academy classes to be held in Norfolk, Virginia; and

WHEREAS, Assistant City Clerk Diane Carter has received a scholarship award for \$1,066.00 from the Maryland Municipal Clerks Association for her registration fees.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND THAT the City's Fiscal Year 2018 General Fund Budget be amended as follows:

- 1) Increase Revenue (01000-456911) 1,066.00
- 2) Increase Training (11100-555504) 1,066.00


