ORDINANCE NO. 2491

AN ORDINANCE OF THE CITY OF SALISBURY FOR THE CLOSING OF A PORTION OF SOUTH DIVISION STREET AT CENTER STREET, SOUTH DIVISION STREET AT WASHINGTON STREET, AND A PORTION OF MITCHELL STREET AT SOUTH SALISBURY BOULEVARD.

WHEREAS, the Salisbury Charter, SC11-2, gives the City charge of all public ways in the City; and

WHEREAS, the closure of the aforementioned portions of South Division Street are being requested by the Department of Infrastructure and Development to improve traffic safety on South Salisbury Boulevard by diverting traffic to a signal controlled intersection at East Vine Street; and

WHEREAS, the closure of this portion of Mitchell Street is being requested by the Department of Infrastructure and Development to improve traffic safety on South Salisbury Boulevard by diverting traffic to a signal controlled intersection at Vine Street or the stop controlled intersection at Newton Street; and

WHEREAS, the Maryland State Highway Administration supports the City of Salisbury in closing access to South Division Street from South Salisbury Boulevard, and to Mitchell Street from South Salisbury Boulevard as shown on Exhibit A; and

WHEREAS, the Maryland State Highway Administration will install curb and sidewalk on both sides of South Salisbury Boulevard at South Division Street, and at Mitchell Street; and

WHEREAS, the City of Salisbury will install curb and sidewalk at South Division Street between Center Street and South Salisbury Boulevard, and South Division Street at the intersection of Cross Street and Washington Street; and

WHEREAS, the City of Salisbury will install bollards behind the sidewalk at the intersection of Mitchell Street and South Salisbury Boulevard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the aforementioned sections of South Division Street and Mitchell Street are hereby closed to vehicular traffic.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon the date of its final passage.



Re: Ordinance to close access to South Division Street and Mitchell Street from Route 13


Salisbury Department of Infrastructure and Development supports the closure of access to South Division Street at Route 13/South Salisbury Boulevard, and access to Mitchell Street at Route 13. The existing configuration of these streets are as follows and are shown on the attached drawing:

- Mitchell Street allowable movements are left/right in, right out. Note that vehicles making a left turn onto Mitchell Street do not have a turn lane on Route 13
- S. Division on west side of Route 13 allowable movements are right in/right out.
- S. Division on each side of Route 13 allowable movements are right in/right out
- No left turns in or out are allowed at South Division Street.

Due to the "S-curve" configuration and the uniquely shaped series of intersections, this area of Route 13 has become a safety hazard. Per the attached data, the Salisbury Police Department has logged approximately 119 vehicle involved collisions along Route 13 from Vine Street to Mitchell Street in the past five years. (Note that the attached data shows 126 incidents. The difference is due to unfounded calls or incidents occurring in a parking lot.) At least four of the incidents logged were hit-and-runs.

A signalized intersection exists at Vine Street, 280 feet north of South Division Street. The closure of access to South Division at that location will not adversely affect motor vehicle traffic. Further, Newton Street intersects Route 13 approximately 270 feet southwest of Mitchell Street, therefore motor vehicle traffic will not be compromised by the closure of access to Mitchell Street. These crossings, while recommended for closure to motor vehicles, will remain accessible to pedestrians. Connection will be provided through the closed access points to accommodate access to the sidewalks provided along Route 13. Further, the planned Rail Trail will pass through the portion of South Division closed on the east side of Route 13 which will provide access to a safer north-south route for pedestrians and cyclists.

Peninsula Regional Medical Center has been contacted and they have indicated that they not only support the closures but that they have no plans to reopen South Division Street to through traffic.



Letters of support from the Maryland State Highway Administration, the Salisbury Fire Department and Peninsula Regional Medical Center are attached. The road will be closed by means of installation of curb, gutter and sidewalk, per the attached Exhibit A. Maryland State Highway Administration will install the portions of concrete in their right-of-way during construction of their Phase 6 Stormwater Project. The Department of Infrastructure and Development will complete the closures on the city portions as appropriate for each location.

Recently the Maryland Department of Transportation State Highway Administration (MDOT SHA) was approached by the City of Salisbury to discuss the closure of Mitchell Street and South Division Street at US 13 BU. After careful consideration of operational and safety impacts, MDOT SHA fully supports the closure of these roads.

Both Mitchell Street and S. Division Street are stop-controlled with access to US 13 BU within the S-curve. By removing these access points and redirecting traffic to the signalized intersection at US 13 BU and Vine Street, conflict points will be reduced resulting in a safer corridor.


