Commissioner Dressell makes a motion to approve the addition portion of the application as submitted. Commissioner Paciga seconds the motion. There being no public comments, the motion carries unanimously.

B. #18-13 – 322 N. Division Street – Monica (Nikki) Thrash represented by Steve Smith Porch Floor Replacement

The property owner, Nikki Thrash, and her contractor, Steve Smith, come forward.

City Staff member, Trish Warrington, presents and enters the Staff Findings.

Commissioner Saxman calls for discussion from the Commission as to whether the structure is a contributing or non-contributing structure. After a discussion among the Commission, Commissioner Auchey makes a motion that this is a non-contributing structure; the motion was seconded by Commissioner Dressel.
