

ORDINANCE NO. 2499

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE CITY'S CAPITAL PROJECT FUND BUDGET AND GRANT FUND TO REALLOCATE FUNDING FOR THE SALISBURY REVITALIZATION RIVERWALK AMPHITHEATER PROJECT.

WHEREAS, Ordinance No. 2423 appropriated funds for the FY 2018 budget; and

WHEREAS, Ordinance No. 2423 allocated Capital Project Appropriations in the amount of \$400,000 of Contributions for the Riverwalk Amphitheater project; and

WHEREAS, Ordinance No. 2482 appropriated funds for the FY 2019 budget; and

WHEREAS, Ordinance No. 2482 allocated Capital Project Appropriations in the amount of \$100,000 of Contributions for the Riverwalk Amphitheater project; and

WHEREAS, the City of Salisbury has received grant funding from the State of Maryland through Senate Bill 186 of the 2018 Maryland General Assembly Session; and

WHEREAS, the State of Maryland has designated the Department of General Services to distribute these funds in the amount of \$500,000; and

WHEREAS, a budget amendment is requested to reclassify the funding from contributions to grants; and

WHEREAS, a transfer of \$500,000 will be made into the Riverwalk Amphitheater Capital Projects Grant accounts from contributions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND THAT THE City's Capital Projects Fund and Grant Fund Budget be and hereby is amended as follows:

Re: Budget Amendment – Riverwalk Amphitheater

The Department of Infrastructure & Development is requesting consideration for a budget amendment to reallocate funding for the Riverwalk Amphitheater project. In both the FY18 and FY19 budgets, the Amphitheater was allocated funding under "Contributions." The total funding allocated in the budget was \$500,000. The City was recently awarded a grant from the State of Maryland through Senate Bill 186 of the 2018 Maryland General Assembly Session in the amount of \$500,000 for Salisbury Revitalization, which includes the Riverwalk Amphitheater. Since the funding is in the form of a grant, not a contribution, a budget amendment is requested to reclassify the funding source.
