**July 03, 2019 (12:50 p.m.)
 (Assault on Police Officer)**

A late afternoon assault on a Salisbury Police officer lands an adult male in jail, while officers continue their search for the wanted subject they were trying to arrest.

On July 02, 2019 at approximately 2:30 p.m., Salisbury Police officers were assisting the Housing and Community Development (HCDD) team with a residential property inspection within the 300 block of Martin Street. While working with HCDD, Salisbury Police officers came upon a wanted subject, identified as 26 year old Jordan Devaughnta Jobe, who happened to be on the property that was being inspected. Upon seeing the police officers, Jobe fled from the residence on foot. Knowing that Jobe was currently wanted for traffic related charges, officers pursued Jobe and ultimately located him on a property across the street.

Officers attempted to arrest Jobe, but he actively resisted the arrest. As officers were trying to take Jobe into custody, 30 year old Daniel Marcus Mapes approached and began assaulting the officers in an effort to free Jobe from being arrested. Mapes punched one of the arresting officers in the face and began pulling the other officer's equipment in a further attempt to free Jobe. The officers' attention was then diverted to Mapes who was actively assaulting and interfering with the arrest of Jobe. With the assistance of Mapes, Jobe was able to free himself and flee on foot to avoid arrest. Mapes was quickly taken into custody without further incident. Mapes was treated and released from Peninsula Regional Medical Center for minor injuries he received during the arrest. Mapes was then transported and released to the Wicomico County Detention Center where he is being held without bond. The officers did receive minor injuries as a result of this incident that did not require medical treatment.

A search of property that Jobe was carrying at the time of this incident revealed an amount of controlled dangerous substance. Jobe is now currently wanted on two separate warrants and the search for him will continue until he is arrested. The Salisbury Police Department would also like to view any private video that was captured by witnesses of this incident, so please contact S.P.D at (833)SBY-CITY if you do have video and would like to share it with us. We are also requesting the assistance of the public in locating Jobe.
