#18-50 – 313 Maryland Ave- Salisbury Neighborhood Housing Services, Inc
-Demolition/Exterior Alterations

Anthony, Nester Bleach, Lauren Wyndell and Cheryl meadows came forward to present the case. The property was deemed contributing after a motion of approval by Commissioner Frederick and second motion by commissioner Paciga. Nester Bleach presented the case to ask for approval of the following:

Demolition of front porch, chimney and garage- All approved

Masonry/ Concrete – 8 inch reinforced 3000 PSI concrete footer- Approved

Roofing- replacing with same shingles as existing – Approved

Siding- New wood - Approved

Windows- Vinyl Windows- not approved but will allow wood, fiberglass or aluminum covered wood

Doors-Rotted sill around doors to be replaced- Approved

Porches- Approved but not wrapped in vinyl

Painting- Approved

Landscaping- Approved

Railings- Vinyl railings to be installed in place of iron railings- Approved

Nester decided to withdraw the window part of the renovations and to seek approval of the rest. Brenden Frederick Approved the case as amended. Alex Paciga seconds the motion.

-Siding/Railings**

Benjamin Mason and Albert Broughton comes forward to present the case. The property was deemed contributing after a motion of approval by Commissioner Frederick and second motion by Commissioner Paciga. Albert Broughton gives background on the house and states the house has been through 2 fires which caused a ton of damage to the property. There was no lead to be detected inside. Albert is asking for approval for Vinyl siding, Facias and soffit railings. Siding was deemed to be continued and Columns, railings and soffit to be composite or wood. Brenden Frederick made a motion to approve columns, railing and soffit and to revisit the siding in a continuance for a later meeting. Alex Paciga seconds the motion.


