(Arrest- Armed Robbery Investigations)

Detectives charge one suspect as a result of three robberies that occurred between Saturday and Sunday.

On August 8, 2020 at approximately 4:02 a.m., members of the Salisbury Police Department responded to the 7-11 Convenience Store, located at 516 Springhill Rd., in reference to an armed robbery. Police personnel were able to determine that the suspect had approached the store employee, displayed a handgun, and demanded money from the employee. The suspect then fled the area on foot after obtaining an undisclosed amount of US currency.

On August 8, 2020 at approximately 9:53 p.m., members of the Salisbury Police Department responded to Church's Market, located at 739 E. Church St., in reference to an armed robbery. Police personnel were able to determine that the suspect approached the store owner, displayed a handgun, and demanded money from the owner. The suspect then fled the area on foot after obtaining an undisclosed amount of US currency.

On August 9, 2020 at approximately 12:30 p.m., members of the Salisbury Police Department responded to Pizza City, located at 301 E. Carroll St., in reference to an armed robbery. Police personnel were able to determine that the suspect engaged in conversation with an employee. During the conversation, the suspect provided the employee a note that threatened the employee with bodily harm if the employee did not provide the suspect with money. The suspect then fled the area on foot after obtaining an undisclosed amount of US currency. Shortly thereafter, a K9 track was conducted that led officers to the area of Buena Vista Ave., which is in close proximity to Pizza City. A male subject, identified as 31 year old Tyrone Torell Camper, was located in the area of Buena Vista Ave. and Park Heights Ave. Camper matched the description of the suspect in this incident as well as the two previous incidents. Camper was in possession of a Gecado Modell 11 .25 caliber semi-automatic handgun. Camper was ultimately placed under arrest for this incident.

Through the course of the investigation, detectives were able to determine that Camper was the individual responsible for all three robberies. Additionally, Camper was found to be a prohibited person from possessing a regulated firearm. Camper was transported to the Salisbury Police Department and later released to the Wicomico County Detention Center to be seen by a District Court commissioner.

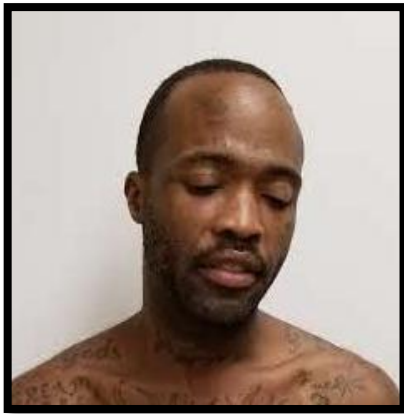
