(Arrest- Fatal Motor Vehicle Collision)

On August 31, 2020 at approximately 9:32 in the evening, officers of the Salisbury Police Department responded to the 1100 block of West Road to investigate a report of a bicyclist struck by a vehicle. Upon arrival officers observed members of Salisbury EMS rendering treatment to the bicyclist for significant injuries. Officers also observed a bicycle in the roadway with damage consistent with having been struck by a motor vehicle. EMS transported the bicyclist to the Peninsula Regional Medical Center (PRMC) where the bicyclist was shortly thereafter pronounced deceased due to injuries allegedly sustained from the collision. The bicyclist has been identified as 64 year old Kenneth Walker, of Salisbury, Maryland, and Mr. Walker's next of kin were notified.

The Wicomico County Sheriff's Office was contacted and responded to conduct the reconstruction of the crash scene.

The investigation by members of the Salisbury Police Department, Wicomico County Sheriff's Office, and State's Attorney's Office for Wicomico County revealed that 35 year old Durell Robins, of Salisbury, MD, was operating a motor vehicle and traveling northbound on West Road. The vehicle Mr. Robins was operating allegedly struck Mr. Walker while the motorist and cyclist were in the 1100 block of West Road. Mr. Robins failed to stop and render assistance to Mr. Walker and left the scene of the collision.

Mr. Robins responded to the Salisbury Police Department where he was placed under arrest and transported to the Wicomico County Detention Center where he was seen by a District Court Commissioner.
