(Arrests/Wanted-Home Invasion Investigation)

Two suspects are in custody and one suspect remains at large as a result of a home invasion that occurred early Monday morning.

On February 2, 2021, at approximately 3:40 in the morning, officers from the Salisbury Police Department responded to a residence within the 400 block of Liberty Street to investigate a reported disturbance. As the initial officer arrived in the area the officer heard a single gunshot coming from within the residence. The officer then met with a 21-year-old female resident who was yelling for help and a 22-year-old male resident. The victims advised that five males had just fled from the rear of their residence, entered a motor vehicle, and left the area. The male victim advised he was familiar with the suspects.

The male victim further advised that prior to his call to the police he observed approximately five individuals surrounding his vehicle to include 17-year-old Micah Belote, 21-year-old Jordan Jean Pierre and a 14-year-old juvenile. The male victim exchanged words with the subjects in belief that they were tampering with his vehicle. The male victim stated that he observed the three suspects start walking toward the residence, and observed that one of the suspects, Micah Belote, was in possession of a handgun. Mr. Belote and 21-year-old Mr. Jordan Jean Pierre then entered the residence while Mr. Belote was allegedly pointing the handgun at the victims. The 14-year-old remained just outside the entrance. Mr. Belote allegedly fired one shot in the direction of the victims. Mr. Belote, Mr. Jean Pierre and the 14-year-old then fled the scene in a motor vehicle.

A description of the vehicle was broadcast to officers who subsequently located the vehicle and conducted a traffic stop in the area of E. Isabella Street and Naylor Street. Mr. Jean Pierre was identified as the driver. Officers also located the 14-year-old male within the vehicle. Both males were positively identified and subsequently placed under arrest. Mr. Jean Pierre (pictured below) and the 14-year-old male suspect were transported to the Salisbury Police Department. Mr. Jean Pierre was later transported to the Wicomico County Detention Center where he had an initial appearance before a District Court Commissioner. The 14-year-old male suspect was released to the care and custody of the Lower Eastern Shore Children's Center. An application for charges was submitted to the District Court Commissioner's Office and an arrest warrant was issued for Mr. Belote. Mr. Belote is currently 17 years-of-age; however, due to the nature of the crime Mr. Belote was charged as an adult.

Officers and detectives were able to process the scene of the incident wherein they recovered evidence indicative of a firearms incident having occurred.

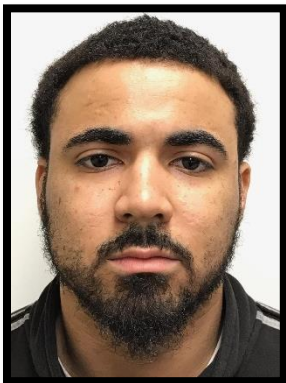

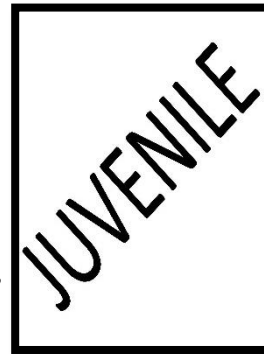
