Detectives charge suspect Thursday afternoon for multiple incidents of indecent exposure.

On February 26, 2021 at approximately 4:46 in the afternoon officers from the Salisbury Police Department responded to the 100 block of S. Division Street, and met with a 30-year-old female victim. The victim advised that while parked in her vehicle in the area she was contacted by a male suspect who was carrying a cellular phone. During the contact, the male suspect exposed his genitals to the victim. The suspect then fled on foot.

On March 1, 2021 at approximately 5:40 in the evening officers of the Salisbury Police Department responded to a business on the 200 block of Lemmon Hill Lane. Officers met with a 38-year-old female victim. The victim advised that she was working in her office building when she was contacted by a male suspect knocking at the business door. The suspect asked her about acquiring services from her business. When the victim went to provide the suspect a business card she observed that the suspect's genitals were exposed. The victim immediately returned to her office and contacted the police.

Officers met with a 50-year-old female victim, who advised that on March 1, 2021 at approximately 5:15 in the evening she was parked in her vehicle in the W. Market Street area. The victim advised that she observed a male suspect approach the rear of her vehicle. The victim observed that the male suspect had his genitals exposed. The victim immediately fled the area and subsequently reported this incident to police.

No injuries have been reported by any of the victims. Through the course of the investigation, detectives were able to identify 21-year-old Amon Walston (pictured below) as the suspect in these incidents. An application for charges was submitted to the District Court Commissioner's Office wherein a criminal summons was issued for Mr. Walston.

On March 4, 2021 at approximately 4:40 in the afternoon detectives responded to the 500 block of Overbrook Drive and served Mr. Walston with the criminal summons.
