(Arrest -Burglary and Theft from Motor Vehicle Investigation)

Salisbury Police make arrest Thursday after connecting suspect to burglary and theft from motor vehicle.

On June 21, 2021, at approximately 7:36 in the morning, a Salisbury Police Officer responded to the 300 block of Camden Avenue and met with a 25-year-old male victim who reported that he had parked his vehicle in front of his residence during the overnight of June 20, 2021. The victim reported that when he returned to his vehicle the next morning, several power tools had been removed from his vehicle by an unknown suspect.

On September 14, 2021, at approximately 10:49 in the evening, officers from the Salisbury Police Department responded to a residence on the 200 block of South Boulevard and met with a 21-year-old male victim and a 22-year-old male victim who reported that their residence had been broken into. The victims advised that they had left their residence on that same evening between the hours of 9:15 and 10:00pm. When they returned home they immediately observed that their residence had been unlawfully entered. One of the victims reported that he had firearms stolen from the residence while the other victim reported that he had numerous clothing items stolen.

Through the course of these investigations detectives were able to identify 43-year-old Quincey Wilkins (pictured below) as the suspect in both incidents. On September 16, 2021, at approximately 2:00 in the afternoon detectives located Mr. Wilkins at a residence within the 1100 block of Parsons Road and shortly thereafter placed him under arrest for an unrelated District Court bench warrant. During the arrest, numerous items of evidentiary value were located.

Mr. Wilkins was transported to the Salisbury Police Department and later to the Wicomico County Detention Center where he was seen by a District Court Commissioner. Applications for charges were submitted to the District Court Commissioner's Office for both incidents wherein an arrest warrant was issued for Mr. Wilkins in relation to the burglary incident and a criminal summons was issued for the theft from motor vehicle incident. Mr. Wilkins was served with both documents shortly after his transport to the Wicomico County Detention Center.

These investigations are ongoing and the Salisbury Police Department is requesting anyone with information regarding these incidents to contact the Salisbury Police Department Criminal Investigation Division at (410) 548-3165. 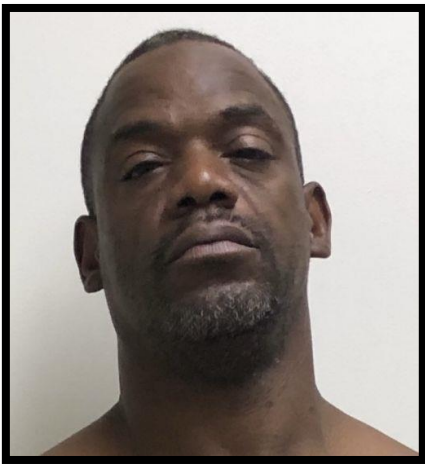
