Salisbury police arrest suspect after investigation into an assault with firearm that occurred early Friday morning.

On February 11, 2022 at approximately 1:42 in the morning, officers from the Salisbury Police Department responded to Guido's Burritos, 1303 S. Salisbury Boulevard, for reports of shots fired in the parking lot. Upon their arrival, officers observed that the business had sustained damage by apparent gunfire.

The investigation revealed that a male patron of the business had a verbal confrontation with the business' security personnel resulting in the patron being removed from the establishment. The male patron is then alleged to have returned to his vehicle wherein he obtained a handgun, fired one shot in the air, and subsequently fired multiple shots while taking aim at a 51-year-old male victim. The patron was then observed fleeing the area in a vehicle. No one was injured as a result of the gunshots, however, there was visible property damage.

During the course of the investigation, Salisbury Police detectives were able to identify 23-year-old Jeremy Taylor as the suspect involved in this incident. Later the same morning of the incident, at approximately 11:50, Mr. Taylor was observed traveling in a vehicle within the 800 block of Priscilla Street. A traffic stop was conducted by police personnel and Mr. Taylor was taken into custody without incident. Mr. Taylor was transported to the Salisbury Police Department and later released to the Wicomico County Detention Center for an initial appearance before a District Court Commissioner.

Applications for search and seizure warrants for Mr. Taylor's residence and vehicle were presented to a judge of the Circuit Court for Wicomico County. The applications were signed and at approximately 1:40 in the afternoon members of the Salisbury Police Department, Wicomico County Sheriff's Office, and Maryland State Police served the search and seizure warrant on Mr. Taylor's vehicle and residence, which were both located on the 200 block of Pond Street.

As a result of the search and seizure warrants, items of evidentiary value in connection with the shooting incident were seized. In addition, US currency and suspected marijuana in an amount consistent with intent to distribute were seized. A semi-automatic handgun, a loaded semi-automatic rifle and ammunition for each weapon were also located and recovered.

The Salisbury Police Department would like to thank the members of the Wicomico Sheriff's Office and Maryland State Police for their assistance in this collaborative effort in keeping the residents of our community safe.
