**(Arrests -Burglary Investigations)**

During the month of February 2022, members of the Salisbury Police Department began investigating commercial burglaries to pharmacies wherein controlled dangerous substances were stolen from the businesses.

On February 16, 2022 at approximately 3:29 in the morning officers of the Salisbury Police Department responded to the Karemore Pharmacy, 817 Snow Hill Road, for the report of an activated burglary alarm. The preliminary investigation revealed that two masked subjects had made forced entry into the business by prying the door open and then stole controlled dangerous substances. The subjects then fled prior to police arrival.

Similarly, on February 26, 2022 at approximately 3:30 in the morning officers were dispatched to the Milford Street Pharmacy, 106 Milford Street, for the report of an activated burglary alarm. Officers learned that two masked subjects had also made forced entry into this pharmacy by prying open a door and stole controlled dangerous substances as well. The subjects had also fled from this scene prior to the officers' arrival.

Through the course of these investigations, detectives made contact with investigators of the Howard County Police Department, who were also investigating commercial burglaries to pharmacies. Detectives developed 35-year-old Harold Dorman and 53-year-old William Sherod as potential suspects in the burglaries.

On April 12, 2022 at approximately 2:55 in the morning covert surveillance was being conducted in the area of the Delmarva Pharmacy, 1615 Tree Sap Court, when investigators observed two masked subjects enter the closed business by prying open the rear door. Members of the Howard County Police Department, Maryland State Police and the Salisbury Police Department then surrounded the business and were able to take the two subjects into custody without incident. The first subject was identified as Mr. Dorman and the second was identified as 29-year-old Deontae Britton. Simultaneously, Mr. Sherod was conducting counter surveillance in close proximity of the Delmarva Pharmacy. Mr. Sherod was contacted by detectives and also taken into custody without incident.

Further investigation revealed that Mr. Dorman, Mr. Sherod, and Mr. Britton were responsible for the Karemore and Milford Street Pharmacies as well. All three men were placed under arrest, transported to the Salisbury Police Department, and later released to the Wicomico County Detention Center for initial appearances before a District Court Commissioner.

The Salisbury Police Department would like to thank the members of the Howard County Police Department and the Maryland State Police for their assistance in this collaborative effort in keeping the residents of our community safe.




