

ORDINANCE NO. 2415

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE FY 2017 GENERAL FUND BUDGET TO REALLOCATE A DONATION PREVIOUSLY ACCEPTED TO REIMBURSE THE PURCHASE OF SUMMER YOUTH EMPLOYMENT UNIFORMS.

WHEREAS, in the summer of 2016, the City established a pilot program geared at employing ten youth ages 16-24, who were either in or out of school; and

WHEREAS, the youth received uniforms that were paid for in whole by the City; and

WHEREAS, the Greater Salisbury Committee has donated funds to reimburse the City for the Summer Youth Work Program uniforms for the amount of \$756.15; and

WHEREAS, the City's FY 2017 budget was amended to include an appropriation of the \$756.15 donated by the Greater Salisbury Committee; and

WHEREAS, the City must now transfer the appropriated \$756.15 to the account which originally paid for the uniforms; and


WHEREAS, the Summer Youth Work Program uniforms were originally paid for by the Water & Sewer account.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND THAT THE City's Fiscal Year 2017 General Fund Budget be and hereby is amended as follows:


- 1) Decrease Miscellaneous Revenue (01000-456911) by \$756.15.
- 2) Increase Water & Sewer (86083-502083) by \$756.15.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on this 23 day of January 2017, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the 13 day of February, 2017.

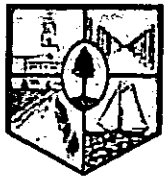
