

ORDINANCE NO. 2432

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING AN AMENDMENT OF THE CITY'S CAPITAL PROJECT FUND BUDGET TO REALLOCATE FUNDING FOR THE MAIN STREET MASTERPLAN PROJECT.

WHEREAS, Ordinance No. 2332 appropriated funds for the FY 2016 budget; and

WHEREAS, Ordinance No. 2332 allocated Capital Project Appropriations for the Main Street Masterplan project; and

WHEREAS, unforeseen site conditions has caused the Main Street Masterplan project to exceed initial budget estimates; and

WHEREAS, a budget amendment is requested to fund project contingency; and


WHEREAS, a transfer of \$600,000 will be made into the Main Street Masterplan Capital Projects accounts from existing unallocated lawsuit proceeds.



Re: Budget Amendment – Main Street Masterplan

The Department of Infrastructure & Development is requesting consideration for a budget amendment to reallocate funding for the Main Street Masterplan project. Additional funding is required for construction contingency of the initial phase of the Main Street Masterplan from Route 13 to Division Street. The additional contingency is due to soil contamination encountered in the first block. We are continuing to work with the Maryland Department of the Environment to implement the most cost effective mitigation and to define the extent of contamination.

We recommend reallocating funds from unallocated litigation proceeds from the prior WWTP upgrade. The litigation proceeds have previously been allocated to fund various water and sewer infrastructure projects. The remaining proceeds have been held for contingency on those and other capital projects. If the contingency funds are not expended during this phase of the project, then they will be available for use during the next phase of Main Street Masterplan construction.
