## ORDINANCE No. 2469

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET AMENDMENT OF THE FY18 GENERAL FUND BUDGET TO APPROPRIATE INSURANCE PROCEEDS RECEIVED IN FY18 TO AID IN THE PURCHASE OF A NEW VEHICLE FOR THE POLICE FLEET.

WHEREAS, Salisbury Police Animal Control Unit #AC2, a 2009 Ford F150 King Cab, VIN 1FIRX12V39FA4443 was involved in a motor vehicle accident and deemed a total loss; and

WHEREAS, the Animal Control Vehicle #AC2 is valued at \$11,650 and the insurance payout to the city of Salisbury was \$10,650 after deductible; and

WHEREAS, SPD is requesting the insurance adjustment for vehicle #AC2 in the amount of \$10,650 be placed in the SPD Police Services, Vehicle Account, 21021-577025; and

WHEREAS, the replacement of the Animal Control vehicle will allow SPD to maintain a sufficient number of Animal Control vehicles to effectively patrol all areas of the City; and

WHEREAS, SPD will utilize the funds appropriated from the insurance adjustment along with other surplus funds to purchase a new Animal Control vehicle.


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the City's Fiscal Year 2018 General Fund Budget and is hereby, amended as follows:

- 1) Increase Insurance Proceeds (01000-456935) by \$10,650.00
- 2) Increase the Police Department budget by \$10,650.00

BE IT FURTHER ORDAINED that this Ordinance shall take effect from and after the date of its final passage.

THIS ORDINANCE was introduced and read at a meeting of the Council of the City of Salisbury held on this <u>13</u><sup>th</sup> day of <u>November</u>, 2017, and thereafter, a statement of the substance of the Ordinance having been published as required by law, was finally passed by the Council on the <u>21</u><sup>th</sup> day of <u>November</u>, 2017.
