

RESOLUTION NO. 2828

A RESOLUTION OF THE CITY OF SALISBURY, MARYLAND ACCEPTING THE DONATION OF MONEY FROM THE CLAUDELL BOWDLE, JR. REVOCABLE TRUST FOR THE SALISBURY FIRE DEPARTMENT TO USE IN EFFORTS TO ENHANCE ITS CAPABILITIES IN PROVIDING THE EFFECTIVE AND EFFICIENT DELIVERY OF FIRE, RESCUE AND EMERGENCY MEDICAL SERVICES AND TO IMPROVE THE QUALITY OF LIFE FOR THE CITIZENS OF THE CITY OF SALISBURY AND THE SALISBURY FIRE DISTRICT.

WHEREAS, the City of Salisbury Fire Department was notified by the Claudell Bowdle, Jr. Revocable Trust (Trust) that it was named as a beneficiary of the Trust; and

WHEREAS, the Trust has executed the distribution of funds in the amount of \$120,958.47, pursuant to Article IV.B.2.b of the Trust; and

WHEREAS, the City of Salisbury Fire Department is in receipt of monies equal to its share as outlined in the Trust; and

WHEREAS, funds appropriated are to be used enhance its capabilities in providing the effective and efficient delivery of fire, rescue and emergency medical services; and

WHEREAS, the City's gifting policy requires that such gifts can only be accepted with the approval of City Council.

NOW, THEREFORE BE IT RESOLVED that the City of Salisbury accept this gift of \$120,958.47 on behalf of the Salisbury Fire Department and expresses its sincere appreciation to the Claudell Bowdle, Jr. Revocable Trust for their generosity,

THE ABOVE RESOLUTION was introduced and duly passed at a meeting of the Council of the City of Salisbury, Maryland held on the 26th day of March, 2018, and is to become effective immediately upon adoption.


