WHEREAS, the City wishes to provide a public skatepark for our local youth that is free of charge, so that they may continue to enjoy what is becoming an increasingly popular sport; and



WHEREAS, the City has received a Community Parks & Playgrounds (CP&P) grant from the Maryland Department of Natural Resources for the Salisbury Skatepark, Phase 2; and

WHEREAS, the Salisbury Skatepark Committee, Inc. has offered to donate an additional \$1,500 to expand the budget for Phase 2 of the skatepark, thereby enabling the change order for an additional quarter pipe skating element to be executed.

NOW, THEREFORE, BE IT RESOLVED THAT, the City of Salisbury, Maryland does hereby accept a donation of \$1,500 from the Salisbury Skatepark Committee, Inc. for Phase 2 of the Salisbury Skatepark.


