

RE: Salisbury Zoo Commission Appointment

Chairman Ron Alessi, Sr. has asked me to give you some background information regarding consideration for membership on the Zoo Commission representing the Lower Shore Herb Society located in the Salisbury Zoo.

I was born and raised between Laurel and Delmar. I attended Salisbury State University (as it was known then) for 1-1/2 years then left the college to work at Culver Oldsmobile for five years until my marriage in 1970. When my husband returned from a tour in Viet Nam, I then moved to Colorado Springs, Colorado where my husband was stationed. Soon after my arrival, I began working at Money Oldsmobile and was employed there until our return to Salisbury in 1972. I then worked in the office at W. F. Allen Nursery Farm. We moved to my grandparents' house across the field from my homeplace.

While raising two children, I had part-time jobs at Southern States and City Mortgage Services as well as the business office at SSU. Then I was hired full time at Stephens-Weisner Real Estate working for Victor Stephens and Ruth Stewart and took classes at SSU and obtained a real estate license.

My first marriage ended in divorce in 1983. In 1991, I married my second husband who passed away in July 2010.

I worked for 12 years in administration at Equitable Bank, N.A. which merged with Maryland National Bank then NationsBank. I left NationsBank in 1995 and was hired full time at Webb, Burnett, Cornbrooks, Wilber, Vorhis & Douse, LLP where I was the legal assistant to the senior law partner, K. King Burnett. I retired from that position in 2013 after 18 years.

My granddaughter, Amore' Buonopane, has been a Docent at the Salisbury Zoo for a number of years starting in high school. She currently works in the Ocelot Gift Shop four days a week. She encouraged me to also volunteer at the Zoo after I retired. I took Docent training in June 2015. Since that time, I have accumulated about 800 volunteer hours at the Zoo becoming a Certified Animal Team member and doing C.A.T. care, handling, Zoo2Us, and participating in numerous onsite as well as offsite programs and special events.

Soon after I became a Docent, I joined the Lower Shore Herb Society to help care for the herb garden at the Zoo. We are a small but dedicated group of folks ranging in age from a freshman in college to several octogenarians. I regularly attend our potluck dinner meetings which are held in the Zoo's Education
