A RESOLUTION OF THE CITY OF SALISBURY, MARYLAND TO APPROVE A MARYLAND DEPARTMENT OF NATURAL RESOURCES, COMMUNITY PARKS & PLAYGROUNDS GRANT APPLICATION FOR FUNDING FOR TWO PROJECTS: (1) SALISBURY SKATEPARK, PHASE 2-B (FINAL PHASE) (2) WATERSIDE PARK – RESTROOM / MAINTENANCE BUILDING AND PAVILION.

WHEREAS, the Maryland Department of Natural Resources (DNR) has solicited applications from eligible jurisdictions to apply for funding under the Community Parks & Playgrounds (CP&P) Program for Fiscal Year 2020; and

WHEREAS, the City of Salisbury is eligible to apply for CP&P funds from DNR; and

WHEREAS, the Council of the City of Salisbury recognizes the important role that our local parks, playgrounds and recreational areas play in maintaining a healthy, pleasant, and attractive environment for the enjoyment of our local residents; and

WHEREAS, the Council wishes to rehabilitate, improve and expand the parks, playgrounds and recreational areas within the City of Salisbury in order to improve the quality of life for all citizens.

NOW, THEREFORE, BE IT RESOLVED THAT, the Council of the City of Salisbury, Maryland does hereby authorize the submission of an application to the Maryland Department of Natural Resources for Community Parks & Playgrounds (CP&P) funds to forward the City's recreational initiatives. This will be accomplished by applying for CP&P funds for the following two (2) projects:

1) Salisbury Skatepark, Phase 2-B (Final Phase) - \$164,000

2) Waterside Park – Restroom / Maintenance Building and Pavilion – \$200,000

BE IT FURTHER RESOLVED THAT, Jacob R. Day, Mayor, is authorized and empowered to execute any and all documents required for the submission of this grant application.

THE ABOVE RESOLUTION was introduced and duly passed at a meeting of the Council of the City of Salisbury, Maryland held on August 13, 2018, and is to become effective immediately.

Salisbury Skatepark, Phase 2-B (Final Phase),
Waterside Park - Restroom / Maintenance Building and Pavilion

The City wishes to submit a Community Parks & Playgrounds (CP&P) funding application to the Maryland Department of Natural Resources (DNR) for the FY 2020 funding round. In this application we will be requesting funding for two (2) projects;

- 1) Salisbury Skatepark, Phase 2-B (Final Phase) \$164,000
- 2) Waterside Park Restroom / Maintenance Building & Pavilion \$200,000

The City wishes to apply for funding for Phase 2-B of the Salisbury Skatepark, which will be the final phase of the skatepark. This project will include the design and construction of an additional 3,000 (approx.) square feet of poured-in-place concrete skating surface, a concrete pad for the portable restrooms and concrete stairs leading to the restroom pad, some benches, litter receptacles and a recycling receptacle. The Salisbury Skatepark Committee has pledged to raise an additional \$3,000 in community contributions for Phase 2-B, and the City will contribute another \$3,000 in City funds. The total cost for this project is estimated at \$170,000 (including contingency funds), and the total amount of CP&P funds to be requested for this project is \$164,000.

The City would also like to complete some additional improvements to the Waterside Park, to include the construction of a restroom / maintenance building, the construction of a pavilion, and some water/sewer connectivity and infrastructure improvements. The City will contribute inkind services to the project consisting of the labor costs for water/sewer services and hookups, surveying and site development plans. The total cost for this project is estimated at \$215,000 (including contingency funds), and the total amount of CP&P funds to be requested for this project is \$200,000.

Attached is a copy of the FY 2020 CP&P Grant Proposal List showing the two projects that we are requesting funding for. Also included is a copy of the updated Salisbury Skatepark design drawing showing the proposed layout for Phase 2-B of the skatepark, a site plan for Waterside Park showing the proposed improvements, and a drawing of the restroom / maintenance building to be constructed.

Attached is a Resolution authorizing the submission of the FY 2020 CP&P funding application. Please forward this Resolution to the City Council so that it may be placed on their agenda for the council meeting on August 13, 2018.
