

A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY RESTRICTING PARKING ON THE SOUTH SIDE OF CANAL PARK DRIVE BETWEEN THE PARKING LOT ENTRANCES OF THE EASTERN MOST BUILDING OF COMPLEX G #228 OF CANAL WOODS IN SALISBURY, MARYLAND.

WHEREAS, the section of Canal Park Drive between the parking lot entrances of the eastern most building of complex G #228 of Canal Woods is adjacent to the Canal Woods swimming pool area;

WHEREAS, there is a high volume of traffic on Canal Park Drive in the area of the Canal Woods swimming pool;

WHEREAS, the safety of pedestrians and motorists is at risk by vehicles parked along this section of the roadway restricting visibility.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the south side of Canal Park Drive between the parking lot entrances of the eastern most building of complex G #228 of Canal Woods, be restricted to "No Parking" to address safety issues and increase the visibility of motorists leaving the east end entrance to the complex.
