

Community Foundation

City of Salisbury Homelessness Fund

1. Establishment

On ______, 20___ the City of Salisbury Homelessness Fund (the "Fund"), a non-endowed designated fund, was established at the Community Foundation of the Eastern Shore, Inc. (the "Foundation"), a charitable organization described in sections 501(c)(3) and 509(a)(1) of the Internal Revenue Code. The Fund Representatives understand that gifts to the fund are irrevocable and will be used to maintain a charitable fund of the Foundation, subject to the Foundation's governing documents and bylaws.

2. Administration

The Fund will be effective upon the acceptance of this agreement by the Foundation. The Fund will be administered in accordance with the normal and customary policies for funds of the Foundation (available upon request). The Foundation may receive additional contributions from donors or other individuals or businesses as well as distributions from trusts, wills, private foundations, or donor advised funds to either initially fund or add to this Fund.

3. Distributions

This Fund will be a non-endowed fund to support:

City of Salisbury for use by the Housing and Community Development Department in addressing homelessness

Distributions from the Fund shall be limited to the fund's distributable amount determined in accordance with the Foundation's spending policy. Distributions may be made upon request, or scheduled on an annual, semi-annual, or quarterly basis, as requested in writing by a Representative listed below. The Representatives reserve the right to convert the fund to an endowed fund if the required minimum balances are met.

4. Representatives

The following positions in the City of Salisbury government may serve as representatives to the Fund with respect to amount and timing of distributions of the Fund:

- Mayor, City of Salisbury
- City Administrator, City of Salisbury

Representative privileges do not include the ability to change the Designee stated in section three, above.

5. Variance Power

This Fund is a component fund of the Foundation, and its assets are assets of the Foundation. The Fund is subject to the Foundation's governing instruments including the Foundation's power to modify any

restriction or condition on the distribution of funds for any specified charitable purposes or to specified charitable purposes or to specified organizations if in the sole judgment of the Board of Directors, such restriction or condition becomes, in effect, unnecessary, incapable of fulfillment, or inconsistent with the charitable needs of the community or area served.

6. Fees

The Foundation will assess administrative and investment management fees against the Fund in accordance with the Foundation's published fee schedule, as amended from time to time. The Foundation may also assess the fund to cover any unusual expenses incurred in connection with the contributed assets, including the cost of disposing of them, and in the administration of the Fund.

7. Investments

The assets of the Fund shall be invested according to the Foundation's investment policy, as it may be amended from time to time by the Foundation's Board of Directors. The undersigned acknowledges that investments are subject to market fluctuations and investment results will be allocated to the Fund.

8. Anonymity/Publicity

To recognize and honor our donors, the Foundation's policy is to include our donors' names in publicity about the Foundation unless they wish to remain anonymous.

The undersigned are the founders of the Fund and agree to the terms of this Agreement. This Agreement shall be governed in all respects by the laws of the State of Maryland. Foundation is authorized to amend this agreement to conform to the provisions of any applicable law or government regulation.



The Department is requesting approval of a budget amendment in the amount \$50,000.00 to the FY2023 Fire Department budget, Vehicles' account 24035-534308, to cover the current and expected costs for repairs to FD apparatus for the remainder of FY2023.

As you are aware, the Department received notification that the engines on our Fire Boat were in need of immediate repair. The engine's turbos are leaking and causing exhaust fumes to enter into the crew cabin. Additionally, the engines are due for their one thousand hour service in accordance to manufacture's recommendation. The Department recommends that both the service and repairs be completed at the same time, thus reducing the time the unit would be out of service.

Currently, the Department does not have the funds to cover these repairs in its FY23 budget, due to an unanticipated replacement of multiple fleet vehicle tires, transfer of \$3,500.00 from the Vehicle Account to cover the unfunded increase of insurance on the Fire Boat, and an over-all increase in maintenance cost. At its current balance, the Department's Vehicle Account will not endure to the end of the fiscal year.


It is very unfortunate that we have to make this budget amendment request, but circumstances have made it necessary to do so. The unanticipated expenses for these repairs were impossible to foresee. Without the transfer of these funds, the Department will be forced to defer any future repairs and place major Fire/EMS units out of service (dependent on the severity of the repair need).



7 8 9 10	WHEREAS, the Throw Away Dogs Project is an internationally recognized nonprofit organization that rehomes K-9s deemed unsuitable for their initial purpose by repurposing, retraining and relocating them into Police, Fire, and Veterans services; and
10 11 12 13	WHEREAS, Delmarva K9, Inc. specializes in police dog training and, through its connection to the Throw Away Dogs Project, facilitates the rehoming of such K-9s in the Delmarva region; and
14 15 16	WHEREAS, Delmarva K9, Inc. wishes to donate a repurposed K-9 to the Salisbury Police Department; and
17 18 19	WHEREAS , the donated K-9 at issue was initially purposed for bed bug detection, but was found to be unsuitable for service in that specific training environment; and
20 21 22	WHEREAS, the K-9 has since been found suitable for police duty, and has been successfully certified in Police Patrol Functions; and
23 24	WHEREAS, this trained and certified K-9 has a market value of approximately \$6,000.00; and
25 26 27	WHEREAS, the Salisbury Police Department desires to further train the K-9 to specialize in accelerant (bomb) detection at a cost of \$6,500.00; and
28 29 30 31	WHEREAS, the Salisbury Police Department has the surplus funds available to cover these costs, and has a great need for this type of specialized K-9 given the ever-increasing special events within the City of Salisbury and limited human resources.
