Salisbury Prize guidelines

The committee reviewed the Salisbury Prize program guidelines and criteria and had provided feedback to get the competition open. The committee encouraged paper and online voting available, and wanted to make sure that due process was done to make sure that people could only vote once. The committee discussed whether the competition should be limited to just Salisbury residents, but ultimately decided to open it to all Maryland artists and that one of the criteria would weight more heavily towards those based in Salisbury. That way, all projects of merit would be considered and the scores would adjust accordingly. The committee decided not to theme the Salisbury Prize and wanted to leave it open to receive as many applicants as possible. They also decided to limit applications to one idea per artist.
