

ORDINANCE NO. 2867

AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET AMENDMENT OF THE FY2024 PARKING AUTHORITY FUND BUDGET TO APPROPRIATE FUNDS FOR SALARIES.

WHEREAS, Parking Authority in the City is of high importance; and

WHEREAS, for the remainder of FY2024, there are insufficient funds for Parking Authority salaries and for on- and off-street parking maintenance and updates; and

WHEREAS, the Parking Authority within the Department of Field Operations has a salary budget currently at \$-12,051.79 and a Streets and Lots budget currently at \$1,210.87 for the remainder of FY2024, and

WHEREAS, the Parking Authority within the Department of Field Operation has estimated \$57,000 would be required to properly maintain current salaries and on- and off-street maintenance and updates; and

WHEREAS, the budget amendment as provided herein must be made upon the recommendation of the Mayor and the approval of four-fifths of the Council of the City of Salisbury.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, as follows:

Section 1. The City of Salisbury's Fiscal Year 2024 General Fund Budget be and is hereby amended as follows:

- (a) Increase the Current Year Salary Account (31154-501002) by \$39,000
- (b) Increase the Streets and Lots Account (31154-534304) by \$18,000
- (c) Increase the Current Surplus Available Account (10100-469810) by \$57,000

BE IT FURTHER ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND, as follows:

Section 2. It is the intention of the Mayor and Council of the City of Salisbury that each provision of this Ordinance shall be deemed independent of all other provisions herein.


Section 3. It is further the intention of the Mayor and Council of the City of Salisbury that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged invalid, unconstitutional or otherwise unenforceable under applicable Maryland or federal law, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and all other provisions of this Ordinance shall remain and shall be deemed valid and enforceable.

Section 4. The recitals set forth hereinabove are incorporated into this section of the Ordinance as if such recitals were specifically set forth at length in this Section 4.

Section 5. This Ordinance shall take effect from and after the date of its final passage.

THIS ORDINANCE was introduced and read at a Meeting of the Mayor and Council of the City of Salisbury held on the 13th day of May, 2024 and thereafter, a statement of the substance of the Ordinance having been published as required by law, in the meantime, was finally passed by the Council of the City of Salisbury on the 20th day of May, 2024.
