Re: Station 16 Water Leak

The Fire Department is asking for the money received from the recent refund (\$20,712.20) pertaining to the March 2024 water leak at Station 16. The Fire Department is asking for these funds to be allocated back into the Fire Department Turnout Gear Account, which was used to pay for the damages. This will allow the Department to stay on pace of our annual gear replacement plan. The money that was used for the leak placed the Department behind with ordering and replacing expired fire gear.

3 **AN ORDINANCE OF THE CITY OF SALISBURY APPROVING A BUDGET**
4 **AMENDMENT OF THE FY2025 GENERAL FUND BUDGET TO APPROPRIATE**
5 **FUNDS TO THE SALISBURY FIRE DEPARTMENT'S OPERATING BUDGET.**

7 **WHEREAS**, the City of Salisbury Fire Department Station 16 experienced a major water leak in March of 2024;
8 and

9 **WHEREAS** the Salisbury Fire Department used funds from the FY24 Turnout Gear Account to help cover the
10 cost of repairs caused by the water leak; and

11 **WHEREAS**, the City has received a total of \$20,712.20 from insurance proceeds and deposited the funds in the
12 City Insurance Proceeds Account; and

13 **WHEREAS**, the Fire Department has use for those proceeds and requests that the \$20,712.20 be reallocated to
14 the Fire Department Operating Budget for FY2025; and

15 **WHEREAS**, the budget amendment as provided herein must be made upon the recommendation of the Mayor
16 and the approval of four-fifths of the Council of the City of Salisbury.

18 **NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF**
19 **SALISBURY, MARYLAND**, as follows:

20
21 **Section 1.** The City of Salisbury's Fiscal Year 2025 General Fund Budget be and is hereby amended as follows:

- 22 (a) Increase the Sale of Insurance Proceeds Account (01000-456935) by \$20,712.20; and
23 (b) Increase the Salisbury Fire Department's Turnout Gear Account (24035-546030) by
24 \$20,712.20:

25 **BE IT FURTHER ENACTED AND ORDAINED BY THE COUNCIL OF THE CITY OF SALISBURY,**
26 **MARYLAND**, as follows:

27 **Section 2.** It is the intention of the Mayor and Council of the City of Salisbury that each provision of this
28 Ordinance shall be deemed independent of all other provisions herein.

29 **Section 3.** It is further the intention of the Mayor and Council of the City of Salisbury that if any section,
30 paragraph, subsection, clause or provision of this Ordinance shall be adjudged invalid, unconstitutional or otherwise
31 unenforceable under applicable Maryland or federal law, such adjudication shall apply only to the section, paragraph,
32 subsection, clause or provision so adjudged and all other provisions of this Ordinance shall remain and shall be deemed
33 valid and enforceable.

34 **Section 4.** The recitals set forth hereinabove are incorporated into this section of the Ordinance as if such recitals
35 were specifically set forth at length in this Section 4.

36 **Section 5.** This Ordinance shall take effect from and after the date of its final passage.

38 **THIS ORDINANCE** was introduced and read at a Meeting of the Mayor and Council of the City of Salisbury
39 held on the _____ day of November, 2024 and thereafter, a statement of the substance of the Ordinance having been
40 published as required by law, in the meantime, was finally passed by the Council of the City of Salisbury on the _____
41 day of November, 2024.
