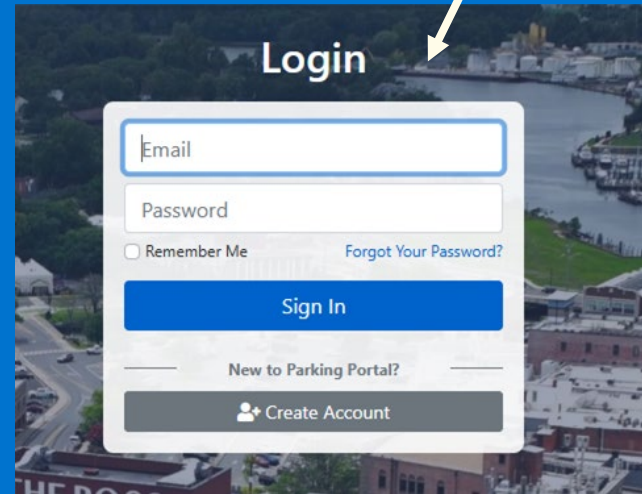

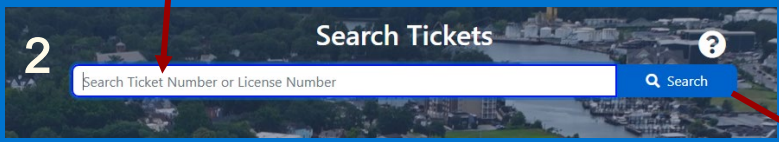

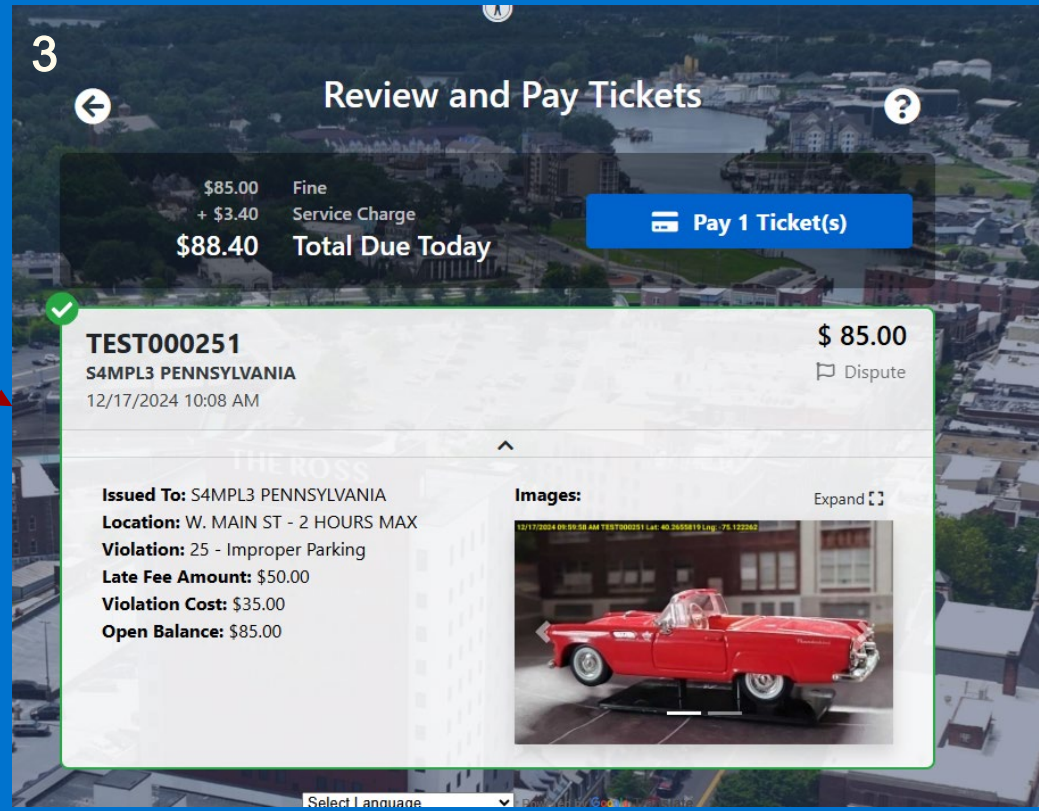

The Maryland General Assembly established procedures for the payment or trial of parking violations.

If you wish to avail yourself of the right to stand trial you must notify the Parking Authority at the Circle Ave Garage 111 Circle Ave., either in person or via the parking portal at least FIVE (5) days before the payment date shown on this notice. If you elect to stand trial, you will be notified of the trial date before the Maryland District Court.

FAILURE TO OBEY THIS CITATION WILL RESULT IN:

1. The state of Motor Vehicle Administration will withhold your automobile tag renewal
2. An additional penalty of \$25.00 will be applied to the fine after 30 days from the violation date, with an additional \$25.00 added after 60 days.
3. Failure to pay parking fines may subject motor vehicle to seizure.

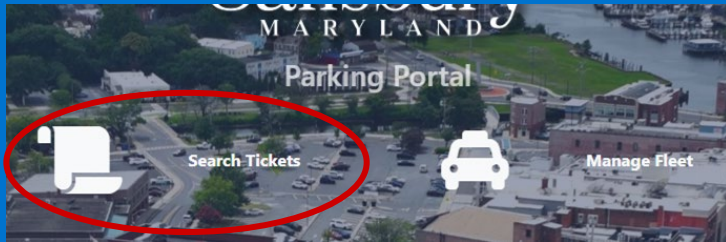

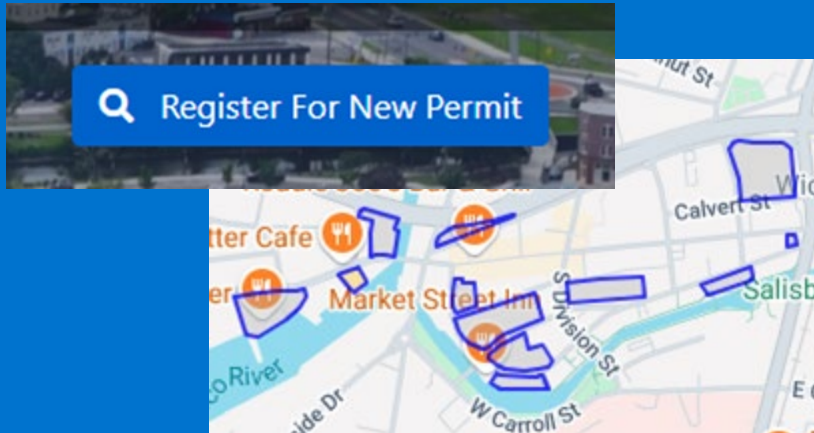
Disputes will be reviewed by Parking Authority staff, with a decision issued within 48 hours. If dissatisfied, you may request a trial through the Parking Authority.
